The graduate is employed in the field of gardening (especially in the floriculture sector, orchard keeping, fruit growing, greengrocery growing and in auxiliary works mainly in reproduction of fruit and ornamental material, floriculture, fruits and vegetables growing, in the establishment and maintenance of orchard and landscaping adaptations and flower arranging and making bouquets.

Examples of possible jobs: gardening works focused on the implementation of manual and less skilled work activities in the horticultural production, such as growing vegetables, ornamental and fruit plants, etc.
